



## **Contract for Service**

An agreement entered into on the 14th January, 2025

between

**The Authority for Integrity in Maltese Sport (AIMS)**

as herein represented by the Chief Executive Officer

and

**Jermain Brincat**



(hereinafter referred to as the 'Contractee')

**CONTRACT FOR SERVICE**  
**Authority for Integrity in Maltese Sport**

**1. Assignment of Duties and Responsibilities**

An agreement is being entered into with Mr. Jermain Brincat [REDACTED] of [REDACTED] Malta, hereunder referred to as the Contractee, to provide **Audio Visual Editing services for TV and social media content** related advisory services to the Authority for Integrity in Maltese Sport (referred as AIMS) - as outlined in Annex A, in connection with, Audio Visual Editing services for TV and social media content matters.

**2. Effective Date and Duration**

This Agreement shall be for the period of one year between 14th January, 2025 and 13<sup>th</sup> January, 2026. This contract will be automatically renewed for an additional year should the following criteria are established:

Contractee fulfils the Authority's requests efficiently.

No unresolved disputes are in place.

Subject to CEO's recommendation in line with the direction at the time.

**3. Payment**

The Contractee shall be paid up to €9,900 (Excluding VAT) for the duration of the contract.

For payment purposes, the Contractee is to send a signed detailed record of work performed endorsed by top management, and an invoice (VAT invoice if applicable) for the work carried out.

The work required is outlined in Annex A.

**4. Applicable Rules and Regulations**

The Contractee shall conform to general Government rules and regulations in force from time to time. For the duration of the Agreement, the Contractee shall act in all respects

according to the instructions or directives as given to the Contractee by the Chief Executive Officer, AIMS. This Agreement shall not create any relationship of employer/employee.

#### 5. Non-Disclosure and Confidentiality

Any information obtained pursuant to any communication or any documentation passed on by AIMS with a view to giving the Contractee a task to perform under this Agreement, shall not be disclosed to any third party or used for purposes other than those for which the information was sought or provided, unless either of the Parties is compelled to disclose such information by a competent Court of Law.

Provided that any dissemination of information to other competent authorities or any use of information other than the purpose for which it was intended or provided shall be subject to the prior written consent of the AIMS and may also be subject to any conditions and restrictions which may need to be imposed.

The Parties agree that information given to the Contractee in pursuance of this Agreement may be of a confidential nature. The Contractee shall thus ensure to implement appropriate and effective measures in order to safeguard the confidentiality of information provided by AIMS in pursuance of this Agreement.

#### 6. Laws and Regulations

This Agreement shall be governed by and construed in accordance with the Laws of Malta. The Parties shall abide by all applicable respective national laws and regulations.

#### 7. Dispute Resolution

In the event that any dispute arises in relation to this Agreement, the Parties shall attempt to resolve tensions and conflicts amicably. Should no solution be found to the disagreement between the Parties within fifteen (15) days from the date on which both Parties become aware of such disagreement, the aggrieved Party shall refer the dispute to the Malta Arbitration Centre.

#### 8. Assignment of Rights

Neither Party shall assign, transfer, or delegate any of its rights, duties, or obligations under this Agreement without the prior written consent of the other Party, which consent may be withheld at the sole discretion of such Party.

#### 9. Termination of contract

AIMS may, without fault or liability and at any time, terminate this contract forthwith at no costs additional to those due in respect of rendered services. On the other hand, the



Contractee may, at any time after expiration of one month from the commencement of this Agreement, terminate this contract by giving one month's notice in writing.

The Parties intending to be legally bound and therefore signing this Agreement on the date set hereunder.
