We act for Dr Konrad Mizzi, who is also a current client of yours pursuant to a Master Fiduciary Services Agreement dated 16 June 2015.

We enclose a signed mandate dated 22 April 2016 authorising this firm to contact you on his behalf, for your records.

Our mutual client is understandably concerned and aggrieved by the recent leak of his private and confidential data from your systems to an investigative news agency. As a consequence of the leak our client is being asked to respond to questions from the media (and beyond) that he is incapable of answering without sight of the entirety of the personal documentation that has been leaked.

On behalf of our mutual client and pursuant to your general client care obligation (as well as your express and implied contractual requirement to provide services to our client with reasonable care and skill), we therefore require you to provide us with a copy of his entire client file.
